President's Message by Alix Shor

It was SCARE's turn to host the 2019 Fall Conference for the California Retired County Employees Association (CRCEA). We had been preparing for this Conference for many months and had lined up some very interesting speakers and there were over 80 people from around the state scheduled to attend. As it turned out, the night before attendees were to begin to arrive, we had to cancel the conference due to the Kincade fire. The silver lining, if there is one under these circumstances, was that the DoubleTree Hotel was able to rent the rooms we would have taken to evacuees who needed a place to stay. And the DoubleTree returned the several thousand dollars that we had on deposit for the conference. They treated us very fairly.

As we promised in the last newsletter, we are prepared to launch an array of insurances offered through the Pacific Group Agencies. Sixteen counties that are part of the 1937 Act Retirement System have been participating for many years with positive experiences. We will be the seventeenth. We have asked Steve Pettee of Pacific Group Agencies to join us at our next membership meeting on February 25th to go over the types of coverage being offered. We are hoping that you will be able to join us. See below for more information on this new benefit.

Now that the conference and the holidays are behind us it is also time for us to look ahead for where we want SCARE to go this year. The Board has been working on a questionnaire to get your input for what you would like to see us tackle. It will be coming out soon and I hope you will take time to get back to us.

Phyris and Bill continue to attend the JLMBC (Joint Labor Management Benefits Committee) to represent our interests regarding health insurance coverage. For those who are covered by the lawsuit settlement, there will be an additional deposit in their HRA (Health Reimbursement Account) on March 1st. New Insurance Benefit through Pacific Group Agencies

As mentioned above, SCARE will be offering additional insurance products to our members. Pacific Group Agencies has been offering this quality group insurance through 16 of the county retiree associations out of the 20 that are grouped with us under the 1937 Act (having our own retirement systems). New Insurance Benefit through Pacific Group Agencies

Pacific Group Agencies offers the following types of insurance: Dental, Vision, Personal Accident, ID Shield, Emergency Assistance Plus, Pet Insurance, Travel Guard, Amplifon Hearing, and more. You will be receiving a Benefits Guide around March 9th that gives you the details on these different insurance plans. It also tells you how to apply for any you are interested in. You choose if you want any of them and if you do, you must pay the cost for them, just as you do now for the County Dental insurance. Payment has to be made through automatic deduction from your bank account.

You currently have access to dental insurance through Sonoma County and access to vision insurance through SCERA. SCARE is coordinating the provision of information on this new benefit with the County Annual Enrollment. You should expect to receive the County Retiree Benefits Guide, the SCERA and VSP Vision Care Open Enrollment information, and the Pacific Group information booklet around the first part of March. This will allow you to compare all the vision and dental insurance plans available to you. If you decide to switch from the County dental insurance, you will want to coordinate those two so there is no gap in between. The Pacific Group Dental is through the Ameritus and Cigna networks whereas the County's is through Delta Dental so you will want to check whether your dentist is in one of those networks.

Steve Pettee of Pacific Group Agencies will be attending our February 25th Membership Meeting to provide you with early copies of the insurance booklet and to answer your questions about this benefit. We want to encourage our members to attend this meeting so we are starting our social at noon and providing sandwiches, pizza or other finger food. We hope you will attend to learn more about this new benefit.

JLMBC Report by Phyris Tobler

New Health Insurance Rates: The Human Resources Department has given us the expected changes to the County insurance rates effective 6/1/2020. Kaiser rates will increase by 4.7% for those under 65 with the cost for 1 person going to \$904, before the \$500 County contribution. For those over 65, cost will decrease by 1.9% with cost for 1 person going to \$331. Kaiser Hawaii increases by 1.4% and Kaiser Northwest increases by 9.8% for under 65 and 3% for Medicare eligible. Sutter rates will increase by 5% going to \$678 for 1 although this may decrease a little. Western Health Advantage will increase by 2.3% with the cost for 1 going to \$800. Neither Sutter nor Western Health Advantage have a Medicare plan. The County Health Plan rates are actually going down a little – a 1.3% decrease for a monthly cost of \$1355 for those under 65 and \$729 for Medicare eligible.

Because the rates for the AARP/United Healthcare insurance are individual and vary by plan chosen, age and area you live in, we are not able to give any rates for that. Cost averages around \$300/month for both medical and prescription coverage. If you are over 65 and not already on the AARP/UHC insurance, you can expect to get packets mailed directly to you that show coverage options for medical insurance and prescription coverage and your cost for these. If you are currently on the County Health Plan, the cost savings is significant, approximately \$3,000/year on premiums and deductible alone, or \$6,000 if you are covering a spouse. Both of you must be Medicare eligible. In Plan F (the best one), there are no deductibles or copays for medical services. One caution: if you are on brand name, high cost prescriptions, the copay can be high so check it out carefully. Note: You can keep your doctor if you are on the County Health Plan and switch to the AARP/UHC plan. The only requirement for AARP/UHC is that the doctor accepts Medicare. If you have questions about the AARP/UHC insurance, you can talk to them directly. You can also get assistance from Care Counsel (888 227-3334)

Annual Enrollment will start 3/16/20 and go for 3 weeks. If you have moved in the last year, be sure that the Human Resources Department has your current address or you won't get your Annual Enrollment booklet.

Vision coverage: You have several options related to vision insurance. There is a free vision discount program through VSP and the County. Information on these discounts can be found in the Annual Enrollment booklet – probably around page 60. There is also a vision insurance plan available through SCERA. You should be receiving one of their open enrollment forms and information about the same time as you get the County Annual Enrollment Booklet. And new this year, SCARE members are eligible for a vision plan through Pacific Group Agencies. This is discussed further on page 1 and 2 of this newsletter. There is a cost for both the SCERA and the Pacific Group plans so you might want to compare them.

HRAs - \$250,000 of the amount awarded to SCARE for the HRAs for members in our settlement with the County was withheld as there was the possibility of their having to pay the "Cadillac Tax" on retiree health benefits. Late in 2019, the US Congress repealed that requirement. Therefore, the County will distribute the \$250,000 to current members of the settlement. They expect this money to be placed in members' accounts by March 1st. Usually there would be a deposit on July 1st based on money that was returned to the pot from members who died without using all their HRA funds. This year, the County will add that amount to the amount you will receive on March 1st. The County will send you a letter giving you the exact amount that is being deposited in your account, but it will probably be around \$100. You can use your current P&A card to access this money.

Good news! The P&A charge for our HRA (only if you have a balance) is decreasing from \$2.95 to \$2.30/month as of January 1, 2020. You will be receiving a new P&A Card around July 1st as the current one expires June 30, 2020. There will be no new deposit of funds in your account at that time but there will be a small deposit in your account on July 1, 2021.

Domestic Partners – a new California law effective January 1, 2020 states that all couples will be allowed to apply for domestic partnership. Until now, this option was only available to same-sex couples and opposite-sex couples over age 62. If you register your domestic partner with the State of California, you can add that person to your County health insurance, meaning they would be eligible for one of the County health plans and if your health plan costs less than \$500/month, the balance can be used to pay for part of their insurance.

Medicare Part B Cost – For your information, especially for those who are soon turning 65: Social Security charges for Medicare Part B. The minimum cost for this as of 2020 is \$144.60. If your income is more than \$87,000 for one or \$174,000 for a couple, your cost increases. This is based on your income from 2018. Retirees are reimbursed \$96.40 by the County and that is added to your pension check. This amount was frozen in 2009 so the reimbursement stays the same even though the Part B cost goes up. If your income is above the \$87,000 figure, the cost for Part B can go up rather dramatically. If this applies to you, go to https://www.medicare.gov/your-medicare-costs/part-b-costs to see what your actual cost would be.

SCARE Scholarships Increased and Applications Due

The SCARE Board voted to increase the scholarships that we make available to children or grand-children of Sonoma County retirees or employees. We now offer three \$1,500 scholarships to SRJC students and two \$3,000 scholarships to SSU students. The SSU application deadline was February 1 but the SRJC deadline is March 2nd so if you know of anyone who might qualify, let them know these scholarships are available. These classes decrease concerns about falls, increase balance, flexibility and strength through these free classes for older adults. Classes include:

SCERA Update Report by John Pels

In October, at SCERA's Planning Session, the Board heard from Segal, the Plan's actuary, about a new risk report required by the Actuarial Standards of Practice. The purpose of this report is to help the Board, participating employers, members and stakeholders understand the risks that plan experience may be different from the actuarial assumptions in place, which may have a significant impact on the plan's future financial condition. Examples of this type of risk include investment risk, where earnings on plan assets differ materially from the investment earnings assumptions, longevity risk where retirees and beneficiaries are living longer than expected, or benefit payments beginning sooner than expected, which can lead to asset/liability mismatch risk where asset values and liabilities deviate from assumptions.

The report noted that SCERA has taken significant strides in risk management and long-term plan sustainability. This includes strengthening of assumptions, particularly the expected investment return, and adopting a funding policy that eliminates negative amortization and promotes intergenerational equity. These changes may result in higher contributions in the short term, but in the medium to longer term will avoid both deferring contributions and allowing unmanaged growth in the UAAL, which is essential for SCERA's fiscal health going forward.

In January, SCERA welcomed Travis Balzarini to the Board. Travis was successful in the general member Trustee election held in December of 2019, unseating Michael Gossman. Travis is a Senior Programmer Analyst with the County's Information Systems Department. Bob Williamson was reappointed to our Board as well. Both Trustee terms of office begin in January 2020. SCERA hired Sal Fuentes, a new Senior Office Assistant, to fill the position vacated by the retirement of Alden Adkins. If you stop by SCERA's office, he will be the first face you see, as he is assigned the front desk duties.

On the investment side of things, SCERA has embarked on its asset/liability modeling (ALM) study which is conducted by the plan's investment consultant, Aon, in conjunction with staff and the plan's actuary, Segal. The Board should hear the results of that study later this year, and will make decisions on the plan's asset allocation, which will then be used by Segal in their experience study for the plan years January 1, 2018 through December 31, 2020. The ALM, which is conducted triennially in the year preceding the experience study, is an important step to take in order to ensure the plan's asset allocation satisfies the expectations and investment philosophy of the Board, and provides an opportunity to make changes if warranted. The results of the study and any potential changes will all be discussed at public Investment Committee meetings this year.
