President's Message by Alix Shor

It's hard to believe it's already August. For those of us who retired prior to June 30, 2016, we have gotten the last of three large contributions to our HRA's based on the SCARE legal settlement with the County. I hope you have been using this benefit, be it to supplement your share of your insurance premium or to pay for things not fully covered by insurance. The County informs us that 760 retirees have still not used any of their HRA. If you fall in this group, go to page 3 in this newsletter for more information on how to use your HRA.

This year is SCARE's turn to host the CRCEA (California Retired County Employees Association) semi-annual conference. CRCEA is made up of the twenty 1937 Act counties (which means they have their own pension plans rather than being a part of CalPERS). The conference will be at the DoubleTree in Rohnert Park from 10/28 to 10/30. We could use some help either prior to the conference putting materials together or with staffing the registration table. Minutes of the SCARE Business Meeting of May 28, 2019

1. Guest Speaker: Bob Bulwa introduced today's guest speaker, Renee Tolliver, Director of Social Services, for the Council on Aging. Renee reported on the 21 programs and services offered by the Agency, including Social Services, Legal, Financial, and Health. Meals on Wheels, Estate Planning, the Sonoma Wine Country Games, Age-Friendly Sonoma County are just a few of the services that require volunteers to be successful. 2. Call to Order: Following Renee's presentation President Alix Shor called the meeting to order.

3. CRCEA: Carol Bauer reported on the CRCEA (California Retired County Employees Association) Conference which will be hosted by SCARE October 28-30, 2019, at the DoubleTree Hotel, Rohnert Park. Carol asked for volunteers to help with the conference (registration, gift bags, decorations for banquet, etc.). Contact Carol at 707-874-9149 or bfuzzy51@aol.com.

3. SCCLO (Sonoma County Coalition of Labor Organizations): Phyris Tobler reported all of the unions are working together. The County is increasing contributions toward health insurance. So far, they are not suggesting depooling retirees from employees. Retirees under 65 could be depooled from actives, which would make their health insurance premiums go up. 1/3 of retirees are under 65, so this could affect a lot of people.

4. JLMBC (Joint Labor Management Benefits Committee): Phyris reported the County would like to get rid of the County Health Plan. However, they must have something for those retirees who have moved out of the area and are under 65 as they are not eligible for other County health plans.

The unions representing Safety employees have agreed to the County paying \$500 per month into a medical trust fund (DSA) or an HRA (SCLEA). The County will no longer pay the \$96.40 reimbursement for Medicare Part B for those retirees. This only affects people who retire after October 2018 and August 2018 for DSA. We don't think SEIU has even been offered this option, or, at least, they have not accepted it.

5. Member Feedback: Phyris asked for feedback from members on the SCARE Newsletter and for speaker suggestions for our Membership Meetings. We would like to know what they like or if there are other things they would like to see.

6. SCARE Luncheon: Alix announced SCARE's next luncheon will be held June 12 at Legends (Bennett Valley Golf Course). This is a barbecue buffet. Fliers were in the last Newsletter and also available on the back table today. The Board agreed at its last meeting to increase the amount the Association pays towards members' lunches to \$10. This will take effect at our September 11th luncheon. Member lunches will be \$20 rather than \$24 (all inclusive). Non-SCARE members will pay \$30.

7. Drawing: 26 members signed the roster for today's meeting. Kay Greczkowski and Gail Goring won the drawing for a free SCARE luncheon at Legends. Thanks to Carl Jackson for conducting the drawings at our Membership Meetings and for collecting the money donations for F.I.S.H. at our luncheons.

8. Adjourn: There being no further business, the meeting was adjourned.

JLMBC Report by Phyris Tobler

Annual enrollment (AE) has been completed. The County always gives us a migration report after AE which shows when retirees and employees switch plans. The County Health Plan (CHP) only has 26 employees left in it. Most employees have gone to Sutter or Kaiser. There are only about 100 retirees under 65 left in the plan. Given that about 85 live in areas that only have CHP available, that is not too surprising. Given the high cost of CHP, especially for non-Medicare folks, it is expected that this group would switch to the much less expensive plans. What is more surprising is that there are about 740 Medicare retirees still in CHP even though they have to pay \$238/month for single and almost \$1,000/month if they have a Medicare dependent. Only 3 people left the CHP PPO this year despite high premium savings if they went to other plans.

As we have mentioned, the County would like to phase out the CHP Plan. Don't get worried. It isn't going to happen really soon. There is the possibility of a national Medicare Advantage Plan that would be very similar to the Kaiser coverage which is quite good—low copays for medical services and prescriptions. It would cost more than Kaiser or current AARP/UHC plans but it would be much less than CHP. It would really help your reps on this committee if we knew why those on Medicare are not switching to less expensive plans—Kaiser or AARP. We understand that you may not want to change your doctor which lets out Kaiser, but you can keep all your doctors if you switch to AARP/UHC when you could save money on other plans. I'd like to hear from Members who are Medicare eligible and have CHP coverage. Question: Why do you stay with CHP? One or more reasons is fine. HRA Update

Our lawsuit settlement required the County to make 3 annual deposits into class members' (those retiring before 6/30/16) HRAs (Health Reimbursement Accounts). The County made their last major deposit into class members' HRAs on July 1, 2019. The amount deposited was \$1,379.86. The reason that it was less than last year's amount was that the settlement agreement allowed the County to withhold \$250,000 in order to pay the ACA "Cadillac Tax" if that tax was still pending. While the collection of this tax has been delayed several times, it has not been repealed. However, there is hope that that may happen as the House has passed a bill to repeal this tax, but it still needs the Senate's approval so you shouldn't hold your breath.

If that bill is passed, the County would then have to distribute the \$250,000. Whether this happens or not, there will be additional small deposits on each July 1st, probably for several years. That is because as class members die with no beneficiaries, any balance they have goes back in the pool to be distributed the following July 1st. The reallocation contribution, as it is called, was \$33.58 this year and it could be something similar next year.

Statistics on usage: As of 6-26-19, 899 people had a zero balance, 1,482 had some balance but **680 members had used none of their HRA**. That means they have \$3,781 minus the \$70 that P&A charges to administer the HRA for 2 years. We think it likely that most of these people are not SCARE members because we have talked and talked about the HRAs and using your money. However, if you read this and you have not used your HRA, think about using it. It's available for pretty much any health related costs you or your spouse have, including your insurance premiums for your County insurance. If you don't have your debit card (looks like a MasterCard and has P&A Group at the top), call P&A at 1-800-688-2611 and ask them to send you a new card. You can call me if you want more info and don't feel comfortable calling P&A.

Magazine and Book Exchange

SCERA Update Report for July 2019 by John Pels

SCERA received its annual financial audit from Brown Armstrong, and as usual, it was an unmodified opinion, which means that SCERA's financial reports presented a fair and accurate picture of SCERA's financial position and that there were no deficiencies in SCERA's internal controls. SCERA has published its Comprehensive Annual Financial Report (CAFR) and its Popular Annual Financial Report (PAFR) for the year ending December 31, 2018. The CAFR contains a detailed look at SCERA's operations, benefits, financial condition and investments for the year and the PAFR summarizes key information into a readable format. Both documents can be found on the SCERA website at <http://scretire.org/Financial/Financial-Reports/>.

SCERA recently hired a new infrastructure manager, Axium, to complement their existing infrastructure manager, IFM. IFM, which is run by a large Australian pension fund, focuses on large infrastructure projects and infuses capital and management expertise into the management of the asset to ensure their success, while Axium focuses on investments in operational and late-stage greenfield development opportunities in core energy, transportation and social infrastructure assets. Greenfield developments are undeveloped land typically being considered for urban development. The Board recently undertook a review of its fixed income portfolio structure and is considering whether to continue its investment in the unconstrained bond market. The Investment Committee will consider options at its August 15th meeting.

The Board heard an update on the various arrangements between SCERA, the County and other plan sponsor agencies, VSP, United Way and SCARE for deductions from retiree payments for health insurance premiums, charitable donations and retiree organization dues. The Board was supportive of the various arrangements provided they did not put an unreasonable burden on SCERA staff, and agreed with staff that a more formal agreement between the United Way and SCERA, as well as SCARE and SCERA, defining the roles and obligations of each entity was appropriate. United Way and SCARE are currently working with SCERA to formalize the agreements.
